

LIABILITY WAIVER FOR "THE HEAT 2020"

TRAINING DEMONSTRATION

Whereas, the undersigned is registered for the "HEAT 2020 " training demonstration (the "Training") at
FDIC 2020

Now THEREFORE, for and in consideration of the privilege of participating in such Training provided by
or on our behalf of Lion Group, Inc. (the "Presenters") at FDIC 2020 exhibition, the undersigned, for
himself/herself, his/her personal representative, heirs and next of kin:

1. Herby states that he/she understands and is aware that firefighting is an extremely dangerous activity carrying the inherent risk of burns, heat stress, heart attack or other injuries related to activities involving a very high degree of physical strain and exertion frequently in hot and stressful conditions;
1. Hereby states that he/she is in good physical condition with no history of cardio-vascular or other medical problems that could be aggravated by participating in strenuous physical activities;
2. Hereby releases, waives, discharges, and covenants not to sue the Presenters, their employees, shareholders, officers, directors, agents, and representatives ("Releasees") for any and all loss or damage, and any claim or demands therefore on account of accident, injury, illness, death or harm of any type arising out of or related to the Training, whether caused by the negligence of any Releasee or otherwise.
3. Hereby agrees to indemnify and hold harmless the Releasees, both individually and collectively, from any loss, liability, damage, or cost they may incur arising out of or related to the Training, whether caused by the negligence of Releasees or otherwise.
4. Hereby assumes full responsibility for any risk of bodily injury, death or property damage arising out of or related to the Training, whether caused by the negligence of Releasees or otherwise.
5. Hereby acknowledges that the activities involved in the Training are of a hazardous nature and contain inherent risks of serious injury and/or death and/or property damage. The undersigned also expressly acknowledges that injuries received may be compounded or increased by negligent rescue operations or procedures of the Releasees or others.
6. Hereby agree that this Liability Waiver extends to all acts of negligence by the Releasees, including negligent rescue operations, and is intended to be as broad and inclusive as is permitted by the laws of Indiana and that if any portion thereof is held invalid, the undersigned agrees that the balance shall continue in full force and effect.

I, the undersigned, have read this waiver of liability, fully understand its terms, understand that I have given up substantial rights by signing it, and have signed it freely and voluntarily without any inducement, assurance, or guarantee being made to me and

intend my signature to be a complete and unconditional release of all liability to the greatest extent allowable by law.
